《CODES OF CONDUCT》

1. Comply with the Chamber's Constitution, rules, regulations by laws, orders and directives made there under and/or all other competent authorities of the Chamber from time to time and/or resolutions of the General Meeting or Committee;
2. Uphold the interest, reputation and positive image of the Chamber;
3. Pay the fees and subscriptions as required in accordance with the Clause 6 of the Chamber's Constitution promptly, inter alia, as follows:
 - a) Any Member whose application for membership has been duly approved shall pay Ringgit Malaysia Five Hundred (RM500.00) only as entrance fee to the Chamber upon admission;
 - b) The annual subscription for the Members shall be Ringgit Malaysia One Thousand Five Hundred (RM1,500.00) only, which shall be paid within one (1) month after the Secretariat issue the payment notice;
 - c) The Committee shall reserve the right to terminate the membership of any Member who defaults in payment of subscription for one (1) year; and
 - d) The Committee may determine the annual additional subscription for the President, Vice Presidents and Committee Members. It shall be paid within one (1) month after the Secretariat issue the payment notice in the following year.
4. Actively attend committee meetings/general meetings/working committee meetings of the Chamber; and
5. Any Members or Committee Members shall not make commitments / undertaking including making decision related to financial matters and shall not sign any contract or memorandum on behalf of the Chamber without written authorisation of the Chamber and/or approval of the Committee Members and/or passed in the General Meeting.
